Research personnel - UNF COVID-19 manual

UNF COVID-19 procedural safety training

- Researchers will have to participate in a training session on the COVID-19 disinfection procedure and the Personal Protective Equipment (PPE) given by Émilie Dessureault.
- Secondly, Émilie Dessureault will watch researchers (evaluation session) run their own study, and guide them in order to make sure they implement all the COVID-19 safety measures.

Prior to your arrival at UNF

- After the evaluation session, you will have access to book scans as you did normally using the UNF booking site.
- When UNF staff confirm your scan, they will assign the unique identifier to the scan, and create two limesurvey documents: an MRI requisition form (to be filled out by researcher), and an MRI safety questionnaire (to be sent to, and filled out by the participant and researcher). - Both documents have to be filled in at least 24h before your scan.
- Additionally, researchers must follow rules distributed by the CRIUGM (see reference document entitled "Procédure_visite_participant_CCSMTL".

Arrival at UNF

- A waiting area has been set up outside of UNF, please use the chairs labelled "UNF".
- At the time of your reservation, please ring the UNF doorbell, the MRI operator will welcome you.
- Everyone who enters UNF will be asked to disinfect hands and put on a new procedural mask.
- Three signs are located on the UNF chairs in the waiting room (2 for researchers, and one for participants), please use appropriate chairs.

MRI room

• Before entering the MRI room you must disinfect your hands and you must wear a visor (one will be provided to you) on top of the procedure mask.

Control room

• In the control room, please une the chairs located at the far end of the room, next to the Biopac or the E-prime computers.

Cleaning procedure

- Gloves, masks and disinfecting wipes are available throughout the UNF.
- Please follow the disinfecting guide *UNF disinfection procedures* that outline the disinfection procedures specific for UNF.
- The division of labour falls as follows: the MRI operator disinfects the MRI
 machine, their areas in the contrôl room and high touch surfaces; researchers
 disinfect the equipment that was used (i.e. button box, biopac leads), as well as
 their area in the control room and in the waiting room.

Testing room

- UNF's testing room (R0743) is available to be used and can be booked using the UNF booking site.
- Prior to entering the room everyone must sanitize their hands, and put on a procedural mask (both are available at the entrance of the room).
- Please turn on the HEPA purifier, if it is not already on.
- The disinfection of this room is done entirely by the researchers using the room, as such you are advised to follow the *General disinfecting procedure* explained in the *UNF disinfection procedures* document.
 - Gloves and disinfecting wipes are available in the room.
 - Disinfection should be done when exiting the testing room.
 - For elderly or vulnerable populations, we suggest you also disinfect surfaces prior to use as well, as a form of extra safety precaution.
